Background

MRC aims to be the nation’s leading humanitarian organization, with Units spanned all over the Maldives. It recruits members and volunteers, implements Programmes, and delivers services in adherence to the Fundamental Principles of the International Red Cross and Red Crescent Movement.

In partnership with the National Disaster Management Authority (NDMA), MRC is supporting the development of the National Risk Register and Assessment (NRRRA) in line with the Maldives' Disaster Risk Reduction Strategy 2024–2030, NDMA's Strategic Plan 2024–2029, and MRC's Strategic Plan 2019–2030. The NRRRA aims to strengthen national-level, multi-hazard risk information and supports evidence-based decision-making, coordinated risk reduction efforts, and long-term resilience building across sectors and communities in the Maldives. The NRRRA characterizes current and future climate and anthropogenic risks faced by the Maldives for the period 2025 to 2045 and consolidates a baseline understanding of current and emerging risks for both natural and anthropogenic fronts, through developing hazard profiles, formulate definitions and local terminologies, and assess the existing control mechanisms in place for response

Scope of Assignment

MRC is seeking to hire a design consultant to develop the design and layout of the National Risk Register and Assessment (NRRRA) Report for publication.

The conceptual design to be developed in consultation with NDMA & MRC along with provided report content, design brief and brand guidelines of both organizations.
2	Design and layout of the National Risk Register and Assessment Report	Completion of design, layout of the full NRRRA Report in accordance with the approved conceptual design. The report must include relevant photos, illustration, tables/figures and overall report layout

Reporting Line

The consultant will report to the Manager, Programmes & Services of Maldivian Red Crescent and is expected to work alongside assigned focal points from National Disaster Management Authority (NDMA).

Qualifications & Experience

The consultant is expected to possess the following qualifications and expertise.

- 1- Proven 3 – 4 years’ experience in graphic and layout designing/publication production
- 2- Excellent knowledge of layout and design in English.
- 3- Proven ability to deliver high quality results under tight deadlines.
- 4- Previous experience in similar design and layout work for national level publication will be an added advantage
- 5- Previous work with MRC or NGO experience in a similar role is highly desirable.
- 6- Feasibility of technical and financial proposal
