#### Background

The Maldivian Red Crescent (MRC) is an independent, voluntary, humanitarian organization, established under the Maldivian Red Crescent Law [Law 7/2009]. Its primary objective is to provide humanitarian aid, prevent and alleviate human suffering. It is the 187th member of the world’s largest humanitarian movement — the International Red Cross and Red Crescent Movement – which every year helps millions of people whose lives have been devastated by crises or conflict. MRC aims to be the nation’s leading humanitarian organization, with Units spanned all over the Maldives. It recruits members and volunteers, implements Programmes, and delivers services in adherence to the Fundamental Principles of the International Red Cross and Red Crescent Movement.

MRC, with support from the International Federation of Red Cross and Red Crescent Societies (IFRC), and the Italian Red Cross, aims to implement the Youth-Led Urban Resilience and Climate Action (YURC) Project to strengthen youth awareness and climate action in the Maldives. The project promotes a youth-centered, community-driven approach to building climate resilience, focusing on strengthening young people’s understanding of climate change, disaster risk reduction, and resilience through creative, practical, and participatory learning approaches.

#### Scope of Assignment

MRC is seeking to hire a consultant to design a Board Game focused on climate and disaster risk reduction. The deliverables will be in alignment with the requirements of the project.

#### Deliverables

Design and develop an educational board game that aims players to learn about climate resilience and disaster preparedness. Deliverables encompass game board design, card sets, rulebook, packaging.

The consultant hired is expected to deliver the following: -

#	Deliverables	Details
1	Design and Layout of the Climate and Disaster Risk Reduction (DRR) Game Board - A4 tabletop version - Large mat version (4 ft x 4 ft)	The board is a 25-space board with differentiated Hazard Spaces, Wild Card Spaces, and Safe Spaces, representing a Maldivian island setting with visual elements relevant to climate and disaster risk reduction themes.
2	Design of X 3 Game cards based on specifications provided by MRC	The game comprises of Hazard, Action, Wild Cards as core components. Each card must be visually distinct, clearly labelled, and easy to read for young players.
3	Design and Layout of pocket size Game rulebook.	The rulebook includes, gameplay instructions, facilitator answer sheet listing all hazard cards and their matching action cards and learning outcomes
4	Design and layout of Game Box Packaging	Design of the game box and packaging, with MRC and YURC project branding incorporated throughout.
5	Print-Ready and Editable Files	Final high-resolution, print-ready files for all board game components, including all editable source files.
6	Language Versions	Design of all board game components to be in English.

7	Revisions and Finalization	Incorporation of feedback from MRC at each stage of the design process, and finalization of all board game designs for production.

### Reporting Line

### Qualifications & Experience

The consultant is expected to possess the following qualifications and expertise.

- 2- Minimum of 2 years' work experience undertaking similar work. Portfolio of previous work, along with references, must be provided.
- 3- Experience in a developing a similar game-based project would be an added advantage.
- 4- Proven ability to deliver high quality results under tight deadlines.
- 5- Previous work with MRC or NGO experience in a similar role is highly desirable.
- 6- Feasibility of financial proposal.

### Fees & Payments

The consultant will be paid after the completion of the deliverables specified above. Consultant will be paid MVR 25,000.
